

The certificate of incorporation of BRAETAN, INC. was filed at the Department of State of the State of New York on August 4, 1987 under the name of LOU LEVY & SONS ACQUISITIONS, INC., the name of said corporation having been changed to BRAETAN, INC. by amendment filed at the Department of State on November 9, 1987.

5. The plan of merger, pursuant to which this Certificate of Merger is being filed, has been adopted by the unanimous written consent of the Board of Directors and shareholders of each corporation.

6. No amendments or changes in the certificate of incorporation of the surviving corporation are to be effected by the merger.




