## TRADEMARK ASSIGNMENT

This Trademark Assignment (this “**Assignment**”) is made as of August 27, 2001 by **DOPACO, INC.**, a Pennsylvania corporation (“**Assignor**”), and **THE FONDA GROUP, INC.**, a Delaware corporation (“**Assignee**”).

WHEREAS, Assignor owns all right, title and interest in the trademark WESTERN SUNSET (Reg. 1. Assignor hereby sells, assigns, and transfers to Assignee, as of the date hereof, its entire right, title and interest in and to the Mark, including the registration for the Mark identified above, and the goodwill of the business symbolized by the Mark, the same to be held and enjoyed by Assignee, its successors and assigns.

2. Assignor further assigns to Assignee all rights to sue, bring actions for and recover and hold damages, profits and other compensation for any and all past and future infringements and unauthorized uses of the Marks.

3. Assignor covenants and agrees that, upon the request of Assignee, at Assignee’s expense, Assignor shall execute all papers, make all rightful oaths, testify on behalf of Assignee, furnish such documents, materials, information and/or assistance, and do all other lawful acts necessary to perfect the assignment of the Marks to Assignee and otherwise carry out the intent of this Assignment.

4. This Assignment shall be binding upon Assignor and Assignor’s successors and assigns.


