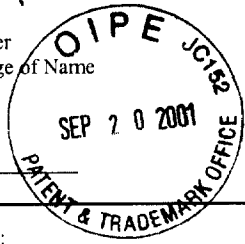





BETWEEN

- (1) **easyGroup Limited (Jersey)** whose registered office is at 38, 39 The Esplanade, St. Helier, Jersey JE4 8WQ, Channel Islands, and whose company registration number is 73113 ("the Assignor");
- (2) **easyGroup IP Licensing Limited** whose registered office is at The Rotunda, 42/43 Gloucester Crescent, London NW1 7DL and whose company registration number is 4060333, incorporated 25 August 2000 ("EIPRco").

WHEREAS:

- A. This deed of assignment is entered into pursuant to an agreement between the Assignor and EIPRco and various other parties dated 5 November 2000 ("the Brand Consolidation Agreement").
- B. The terms and Schedules of this Assignment divide the rights to be assigned into the X Rights, the Y Rights and the Z Rights.
- C. The X & Z Rights are intended by the parties to be licensed by EIPRco pursuant to the terms set out in the Brand Licence (as hereafter defined).
- D. Certain domain names may be held by the Assignor subject to restrictions imposed by national domain name registration rules (including, without limitation, the current rules for the country code top level domains of France (.fr), Ireland (.ie), Estonia (.ie) and Greece (.gr)) which preclude the transfer of the domain name to EIPRco. These are defined herein as "W Rights" and each is to be held by the Assignor as Trustee for EIPRco unless and until EIPRco nominates another party to which that W Right is to be assigned.

THIS DEED WITNESSES THAT THE PARTIES HAVE AGREED as follows:

1. DEFINITIONS

1.1 In this Assignment, the following terms shall have the following meanings:

- "the 1988 Act" means the *Copyright, Designs and Patents Act 1988*;
- "Assignment" means this Assignment;
- "Brand Licence" means the licence granted by EIPRco to **easyGroup** (UK) Limited referred to in the Brand Consolidation Agreement;
- "Business Name" has the same meaning as in the Brand Licence;
- "Copyrights" has the same meaning as in the Brand Licence;
- "Domain Names" means those URLs listed in Schedule 3 together with the right to use and exploit the same;
- "Getup" has the same meaning as in the Brand Licence;
- "Moral Rights" means all moral rights conferred by chapter IV of the 1988 Act or under any laws now or in the future in force in any part of the Territory;
- "Schedule" means a Schedule to this Assignment unless the context shows otherwise;

easyGroup IP Assignment

"Sub-Licence"

means the licence of even date between **easyGroup** (UK) Limited and the Assignor entered into pursuant to clauses 7.2, 7.3 and 7.7 of the Brand Licence;

"Term"

means in perpetuity provided that in the case of copyrights, registered trade marks and other rights, the Term shall be the full period of protection of the intellectual property right in question including all renewals, extensions or revivals;

"Territory"

means the universe;

"Trade Marks"

means all the Assignor's UK, European and other trade marks which are registered or the subject of a pending application, short details of which are contained in Schedule 1 and any other unregistered marks belonging to the Assignor;

"URL"

means a unique resource locator;

"W, X, Y & Z Rights"

means the W Rights, the X Rights, the Y Rights and the Z Rights;

"W Rights"

means the domain names listed in part W of Schedule 3;

"X Rights"

means (a) the Business Name and (b) those of the Copyrights, Trade Marks

and Domain Names that appear in part X of Schedules 1, 2 and 3 respectively;

"Y Rights"

means (a) those rights in respect of which the Assignor is shown as the applicant in Appendix 3 to the Brand Consolidation Agreement and (b) the registered and unregistered trade marks, the copyrights and the domain names that appear in part Y of Schedules 1, 2 and 3 respectively;

"Z Rights"

means (a) the Getup and (b) those of the Trade Marks, Copyrights and Domain Names appearing in part Z of Schedules 1, 2 and 3 respectively.

- 1.2 The singular includes the plural and vice versa. Where this Assignment refers to a collective set of intellectual property rights the reference applies to one, some or all of those rights.
- 1.3 A reference to a clause of this Assignment includes all of its sub-clauses.
- 1.4 A reference to a statute includes a reference to any modification or re-enactment (whether before or after the date hereof) and any subordinate legislation made thereunder.
- 1.5 The Schedules to this Assignment are an integral part of this Assignment.
- 1.6 Headings to clauses in this Assignment are included for ease of reference only and shall have no effect on the construction or interpretation of this Assignment.

2. ASSIGNMENT OF RIGHTS

2.1 In consideration of the covenants and undertakings contained herein the Assignor

2.1.1 hereby assigns absolutely and free from all encumbrances to EIPRco for the Term throughout the Territory all such legal and beneficial rights and title as it may have in and to the X, Y & Z Rights together with the full and exclusive benefit of the goodwill attached thereto together with all accrued causes of action TO HOLD the same unto EIPRco;

2.1.2 shall assign absolutely and free from all encumbrances for the Term throughout the Territory all such legal and beneficial rights and title as it may have in and to each of the W Rights together with the full and exclusive benefit of the goodwill attached thereto together with all accrued causes of action to such party or parties nominated by EIPRco to the Assignor by a notice in writing and pending the service of such notice the Assignor holds each of the W Rights as bare trustee for EIPRco.

2.2 In so far as permitted by law the Assignor hereby irrevocably and unconditionally waives in favour of EIPRco all Moral Rights to which it is now or may at any time in the future be entitled.

3. DOMAIN NAMES

3.1 The Assignor undertakes that it shall at EIPRco's expense as soon as is reasonably practicable after this Assignment becomes unconditional execute any necessary document to procure the registration of EIPRco forthwith as the proprietor of all the Domain Names.

3.2 The Assignor shall deliver up to EIPRco within 30 days of the date of this Assignment or on first receipt if later all certificates of registration or ownership for each Domain Name.

4. **ACKNOWLEDGEMENT**

4.1 The Assignor shall not acquire or claim any right title or interest in or to the Y Rights and the Z Rights hereby assigned to the Assignor whether through the Assignor's use of the Y Rights and Z Rights or otherwise on and after the date hereof other than as may be afforded by the Sub-Licence. All goodwill arising from the use of the rights hereby assigned by the Assignor shall at all times inure to the benefit of EIPRco but shall be licensed to the Assignor subject to the terms of the Brand Licence and the Sub-Licence.

5. **WARRANTIES**

5.1 The Assignor warrants:

5.1.1 that it is the registered proprietor of or otherwise entitled to the W, X, Y & Z Rights as at the date hereof;

5.1.2 that it has not granted any licence right or interest in or to any of the W, X, Y & Z Rights to any other party other than

(a) as set out in the recitals to and clause 2 of the Brand Consolidation Agreement; and

(b) to its subsidiary companies (if any) listed in Schedule 4;

5.1.3 that it has not done any act or omission which invalidates the W, X, Y & Z Rights or the ability of EIPRco to register itself as the proprietor of the registered rights comprised therein;

5.1.4 that all registered intellectual property (including domain names and all applications for registered protection) presently belonging to the Assignor of the character of X & Z Rights has been listed in the

Schedules to this Assignment and all of the Y Rights have been listed either in the Schedules hereto or in Appendix 3 of the Brand Consolidation Agreement and that the Assignor has allotted all such intellectual property rights to parts W, X, Y and Z respectively of the Schedules hereto and to the Appendix referred to above strictly in accordance with the principles set out in the recitals to this Assignment;

5.1.5 that save as permitted under the Brand Licence (or, in the case of W Rights, as permitted hereunder) the Assignor shall not purport to assign, licence, charge or encumber any of the W, X, Y & Z Rights.

5.2 The Assignor hereby agrees and undertakes that for so long as the Brand Licence remains in force it will not seek any registration of any trade mark, domain name, copyright or analogous right which is identical to or similar to any of the W, X, Y & Z Rights in any country in the world except as permitted in the Brand Licence or with the prior written consent of EIPRco. This restriction shall cease in the event that the Assignor becomes entitled to exercise any option to purchase back all or any of the W, X, Y & Z Rights.

5.3 The Assignor undertakes and agrees that it shall at all times observe and perform the terms and conditions contained in this Assignment and indemnify and hold harmless EIPRco from and against all costs and expenses (including, without limitation, legal costs on the indemnity basis, fees and expenses and value added tax thereon), actions, proceedings, claims, demands and damages arising directly or indirectly from a breach of this Assignment by the Assignor.

6. FURTHER ASSURANCE

EIPRco and the Assignor shall and shall procure that all other necessary persons shall at EIPRco's expense execute any further documents, do all acts and things as may be necessary or desirable for giving effect to this

Assignment and complete such other formalities as EIPRco shall reasonably require for the giving of full force and effect to this Assignment.

7. POWER OF ATTORNEY

The Assignor hereby with effect from the date hereof and without time limit irrevocably appoints EIPRco to be the Assignor's true and lawful attorney in the name of the Assignor to execute, sign, seal and deliver all documents, deeds and transfers and to do any other acts and things as may be deemed necessary to effect registrations in the name of EIPRco of the registered rights transferred under this Assignment.

8. WAIVER

The rights of either party (whether arising under this Assignment or under the general law) shall not be capable of being waived or varied otherwise than by an express waiver or variation in writing and in particular any failure to exercise or delay in exercising any of such rights shall not operate as a waiver or variation of that or any other such right. Any defective or partial exercise of any such right by either party shall not preclude any other or further exercise of that or any other such right and no act or course of conduct or negotiation on its part on its behalf shall in any way preclude it from exercising any such right or constitute the suspension of any variation of any such right.

9. MODIFICATIONS

No amendment or modification to this Assignment shall be effective or binding unless it is in writing and executed by the parties hereto and refers to this Assignment.

10. GENERAL

10.1 If any provision of this Assignment is found by any court, tribunal or administrative body of competent jurisdiction to be wholly or partly illegal,

invalid, void, voidable, unenforceable or unreasonable it shall to the extent of such illegality, invalidity, voidness, voidability, unenforceability or unreasonableness be deemed severable and the remaining provisions of this Assignment and the remainder of such provision shall continue in full force and effect.

10.2 This Assignment shall be governed by and construed in accordance with English law. Each of the parties hereby irrevocably submits to the exclusive jurisdiction of the High Court in London (or, if the High Court in accordance with its rules from time to time refers the parties' case to another court, the jurisdiction of that court).

10.3 The rights and obligations set out in this Assignment shall be solely for the benefit of, and shall be enforceable only by, the parties hereto and their respective successors and permitted assigns. A person who is not a party to this Assignment has no right under the *Contract (Rights of Third Parties) Act 1999* to enforce any terms or conditions of this Assignment, but this does not affect any right of a third party which exists or is available apart from that Act.

10.4 The provisions of this Assignment shall be binding upon and shall inure for the benefit of EIPRco, its successors and assigns.

10.5 This deed shall be executed and delivered in two counterparts, each of which shall be considered an original.

10.6 **IN WITNESS WHEREOF** the parties have executed this Assignment as a deed on the date first above written.
