ARTICLES OF AMENDMENT

ARTICLES OF INCORPORATION  
OF  
GRAND BANK OF FLORIDA

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Grand Bank of Florida are hereby amended as follows:

FIRST: Article I of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

The name of the corporation shall be Grand Bank & Trust of Florida and its place of business shall be 2055 Palm Beach Lakes Blvd., West Palm Beach, Palm Beach County, Florida 33409.

SECOND: Article II of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in the lieu thereof:

The general nature of the business to be transacted shall be that of the general commercial banking business, with the right and authority to engage in trust business and act as a fiduciary to the fullest extent permitted by law, and with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers and management of banking corporations.

THIRD: The foregoing amendment was adopted by the holders of the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, acting by written consent without a meeting as of August 10, 2001 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.
