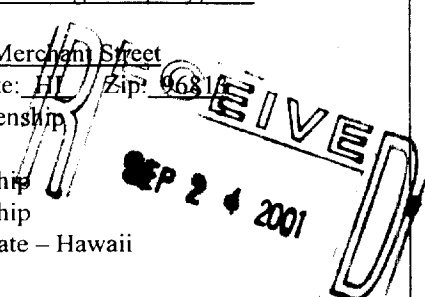



NOW, THEREFORE, the Lender states as follows:


