ASSIGNMENT OF TRADEMARKS

THIS AGREEMENT effective as of the 18th day of June, 2001, is made by and between Vision Legwear, LLC, a limited liability company previously operating and existing under the laws of the state of North Carolina (hereinafter referred to as "ASSIGNOR") and Acme-McCrary Corporation, a corporation operating and existing under the laws of the state of North Carolina and having a place of business at 159 North Street, Asheboro, North Carolina, 27203 (hereinafter referred to as "ASSIGNEE"); and

WHEREAS, ASSIGNEE is the successor-by-merger to ASSIGNOR; and

WHEREAS, ASSIGNOR is the owner of U.S. Registration No. 2065009 for the mark Legs and Design® for hosiery in International Class 25 issued on May 27, 1997; pending use-based U.S. application Serial No. 75/872446 for the mark VISION LEGWEAR™ for hosiery, pantyhose, tights, and socks in International Class 25 filed December 15, 1999; and European Community Trademark Registration No. 000 600 692 for the mark HEALTHY FEET® for hosiery in International Class 25 issued on October 20, 1999 (hereinafter "the Marks");

WHEREAS, ASSIGNEE is a manufacturer and supplier of textile goods such as hosiery items and is using the Marks in interstate commerce in connection with said goods; and

WHEREAS, ASSIGNEE is desirous of acquiring all rights, title, and interest in and to U.S. Registration No. 2065009, pending U.S. application Serial No. 75/872446 and any federal registration which may issue from said application, and European Community Trademark Registration No. 000 600 692.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns, transfers, and sells to ASSIGNEE, its legal representative and assigns, all of ASSIGNOR's rights, title, interest, associated goodwill, and all rights of action against third parties ASSIGNOR may have in the Marks, together with the rights in U.S. Registration No. 2065009, U.S. application Serial No. 75/872,446 and in any federal registration which may issue thereon, and European Community Trademark Registration No. 000 600 692, and to any

renewals and extensions of said registration and application or any foreign registrations which may be granted from any foreign applications, which interest and rights shall be held and enjoyed by ASSIGNEE as fully and entirely as the same would be held by ASSIGNOR to the full end of the terms of said registration and application;

AND, ASSIGNOR hereby warrants and covenants that it has the full power and authority to convey all right, title, and interest in the federal registration and pending application herein assigned, transferred, or sold to ASSIGNEE, and that it has not executed and will not execute any agreement in conflict herewith.

This agreement constitutes the entire agreement between ASSIGNOR and ASSIGNEE. Any amendment, waiver, or discharge of this agreement and any terms, provisions, conditions or breaches hereof, shall be made only in writing signed by both parties hereto.

WHEREAS, this agreement shall be governed and construed under the laws of the state of North Carolina, U.S.A.
