TERMINATION OF PATENTS, TRADEMARKS, COPYRIGHTS AND LICENSES
SECURITY AND PLEDGE AGREEMENT

WHEREAS, XL Flooring Installation Products, Inc., a Georgia corporation (“**XL Flooring**”) having an address of 237 Nance Road N.E., Calhoun, GA 30701, is the owner of the Trademarks, applications and registrations therefor (the “**Trademarks**”) listed on **Schedule “A”** hereto and the goodwill of the business associated therewith; and

WHEREAS, pursuant to that certain Patents, Trademarks, Copyrights and Licenses Security Agreement dated May 24, 2000, by and between First Union National Bank, with offices located at 1339 Chestnut Street, 4th Floor, Widener Building, Philadelphia, PA 19107 (the “**Bank**”) and XL Flooring (the “**Security Agreement**”), XL Flooring granted to the Bank a security interest in and to the Trademarks, the registrations thereof, and the goodwill associated therewith; and

WHEREAS, the parties now desire to terminate the Bank’s security interest in the Trademarks.


NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, the Bank hereby agrees as follows:

1. Effective as of the date hereof, the Security Agreement has terminated, and is of no further force or effect.
2. The Bank hereby releases its security interest and conveys back to XL Flooring all of the Bank’s interest in and to the Trademarks, the registrations thereof and the goodwill associated therewith.
3. The Bank agrees to execute such statements or other documents, as may from time to time be determined to be reasonably necessary, to evidence the release of any and all liens or interests of record in the Trademarks.

IN WITNESS WHEREOF, the undersigned has executed this Termination of Patents, Trademarks, Copyrights and Licenses Security Agreement as of this 28th day of February, 2001.
