

TRADEMARK ASSIGNMENT

WHEREAS, Pfizer Inc., a Delaware corporation having offices at 235 East 42nd Street, New York, New York, 10017, USA, on behalf of itself and its and Affiliates (collectively "Assignor") is the owner of the trademark and service mark registrations and applications, and common law rights pertaining thereto, which may include applications filed on the basis of applicant's bona fide intent to use such marks, listed on the attached Schedule A (collectively, the "Trademarks") and the goodwill of the business symbolized thereby and attaching thereto; and



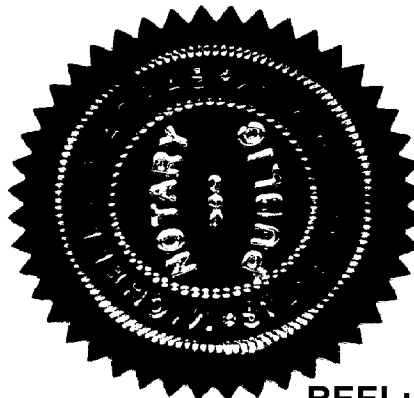
