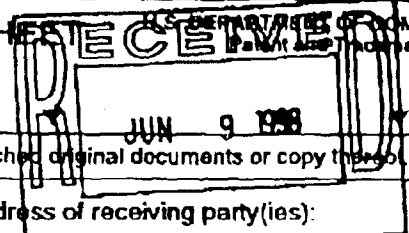

**RELEASE OF TRADEMARK SECURITY INTERESTS**

WHEREAS, Ascent Pediatrics, Inc., a Delaware corporation ("Ascent"), and Triumph-Connecticut Limited Partnership, a Connecticut limited partnership ("Triumph"), entered into a certain Security Agreement (the "Agreement"), dated as of January 31, 1997, which was recorded on February 10, 1997 at Reel 1552 and Frame 0850, that by its terms granted Triumph a security interest in certain intellectual property listed in Exhibit A (the "Trademarks"), all trademark applications and trademark registrations, acquired or arising after the date of the Agreement and all related goodwill;

WHEREAS, the Security Agreement provides that Triumph shall execute and deliver to Ascent a termination of all security interests granted by Ascent upon the payment and full performance of all obligations incurred under the Agreement; and

WHEREAS, Triumph has agreed to release the security interest in the Trademarks.

NOW THEREFORE Triumph hereby releases its security interest in the Trademarks and reassigns to Ascent any interest in the Trademarks acquired by Triumph under the Security Agreement.

IN WITNESS WHEREOF Triumph, by the signature below of its duly authorized representative, agrees to be bound by the provisions of this Release as of the date of execution, this 28th day of May, 1998.
