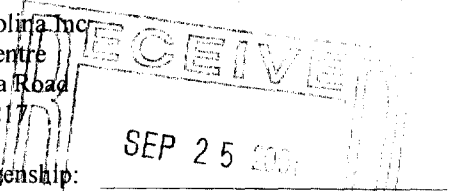


TRADEMARK ASSIGNMENT
