RELEASE OF SPECIFIC TRADEMARKS

RELEASE, dated August 8, 2001 granted by Fleet Capital Corporation, in its capacity as administrative and collateral agent (in such capacity, "Agent").

WITNESSETH:

WHEREAS, GTC Properties, Inc. ("GTC") and Agent, have entered into a Trademark Security Agreement, dated November 14, 1997, (the "Security Agreement"), pursuant to which GTC granted to Agent a security interest in all of the Trademark Collateral (as such term is defined in the Security Agreement);

WHEREAS, the Security Agreement was filed with the United States Trademark and Trademark Office on January 14, 1998 on Reel/Frame 8920/0742 with respect to various trademarks, including, without limitation, the United States trademarks listed on Schedule A attached hereto and forming a part hereof (the "Scheduled Trademarks");

WHEREAS, GTC has requested Agent to release of record its liens upon the Scheduled Trademarks; and

WHEREAS, Agent is willing to release such liens;

NOW, THEREFORE, Agent hereby releases its entire right and interest in the Scheduled Trademarks created by the Security Agreement, and the lien and security interest granted to Agent in the Scheduled Trademarks shall hereupon cease and terminate.

RESOLVED, FURTHER, Agent hereby agrees, at GTC's expense, to execute and deliver all such releases and documents and to take such actions as may be reasonably required to release and terminate the lien and security interest granted to Agent under the Security Agreement.

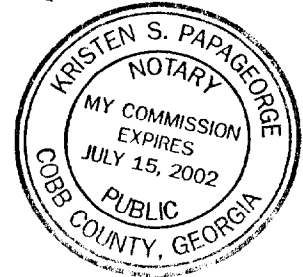
