

ASSIGNMENT OF TRADEMARKS AND ACCOMPANYING GOODWILL

WHEREAS, Cemphar, Inc., a South Carolina corporation, whose address is P.O. Assignor hereby assigns to Assignees all of its rights, title and interest in and to the trademarks and the registration thereof in the United States Patent and Trademark Office, together with the goodwill of the business connected with the use of and symbolized by said marks, and together with any and all interests, claims and rights for damages and profits by reason of any past infringement or unauthorized use of the marks, false designations of origin, unfair competition, deceptive trade practices and/or dilution related to the marks, use of confusingly similar marks or names by others and all other related causes of action and the right to sue therefor.

2. Assignor agrees to perform all reasonable and proper additional acts and to execute any additional documents at the request and expense of Assignees which Assignee may require in order to transfer all of Assignor's rights, title and interest in and to the said trademarks and trademark registrations in Assignee, its successors or assigns.
