ASSIGNMENT OF TRADEMARKS

WHEREAS, HENRY SCHEIN, INC., a Delaware corporation having a principal place of business at 135 Duryea Road, Melville, New York 11747, (hereinafter referred to as "ASSIGNOR"), did on January 31, 2000, pursuant to the License and Distribution Agreements between the parties and in consideration of the rights granted therein, assign all of its right, title and interest in and to the trademark Registration No. 2,158,696, LABNET & DESIGN, (hereinafter referred to as the "TRADEMARK"), including the entire business or portion thereof to which the TRADEMARK pertains, together with the goodwill of the business associated with the TRADEMARK to HSI SERVICE CORP., a Delaware corporation, having a principal place of business at 220 Continental Drive - Suite 115, Newark, Delaware 19713 (hereinafter referred to as "ASSIGNEE");

WHEREAS, the parties desire to formalize and reaffirm said assignment and record same in the U.S. Patent and Trademark Office;

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR ratifies and reaffirms nunc pro tunc the said assignment to ASSIGNEE of the TRADEMARK, the entire business or portion thereof to which the TRADEMARK pertain, and the entire right, title and interest in and to the TRADEMARK together with the goodwill of the business associated with the TRADEMARK; and

ASSIGNOR, does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representative;

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, to record said assignment so as to show ownership of the TRADEMARK in HSI SERVICE CORP., the Assignee; and

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARK and registrations herein assigned.
