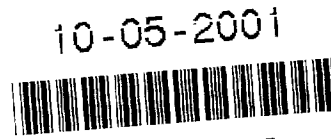

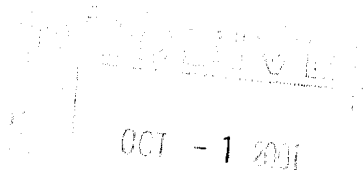

WHEREAS, the **Assignee** is desirous of acquiring said **Assigned Mark**;


