SECURITY INTEREST IN SERVICEMARK(S)

WHEREAS, Collision Team of America, Inc. (f/k/a Church Brothers Collision Repair, Inc.), a Delaware corporation (herein referred to as "Debtor"), has adopted, used and is using the servicemark(s) listed on the annexed Schedule 1 annexed hereto as part hereof, which servicemarks are registered in the United States Patent and Trademark Office (whether one or more than one, the "Servicemarks");

WHEREAS, the Debtor, along with certain other debtors, has executed and delivered a Security Agreement, dated September 28, 2001, by and among the Debtor, such other debtors and Saugatuck Capital Company Limited Partnership III (the "Secured Party") (as same may be amended, supplemented or otherwise modified from time to time, the "Security Agreement"); and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby further grant to the Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
