# WITHDRAWAL OF FILING OF JUDGMENT/LIEN WITH PREJUDICE

This WITHDRAWAL OF FILING OF JUDGMENT/LIEN WITH PREJUDICE, dated as of <sup>August</sup> ~~July~~ 24, 2001, is executed by The Seagram Company Ltd., a Canadian corporation located at 1430 Peel Street, Montreal, Quebec, Canada H3A 1S9 ("Seagram Ltd.").

## WITNESSETH

WHEREAS, pursuant to a certain Judgment After Trial By Court filed by the Superior Court of the State of California for the County of Los Angeles on September 13, 2000 ("Judgment"), Seagram Ltd. received a judgment in its favor and against St. Maarten Spirits Ltd., a Nevada corporation ("Judgment Debtor");

WHEREAS, the Judgment was recorded in the Trademark Division of the United States Patent and Trademark Office as a lien on September 18, 2000, at Reel 002114, Frame 0343 ("Recordation");

WHEREAS, on October 30, 2000, Seagram Ltd. and the Judgment Debtor executed a Settlement and Forbearance Agreement (the "Settlement Agreement"), pursuant to which Seagram Ltd. agreed to withdraw recorded liens subject to the right to re-record the liens in the event that payment was not made to Seagram Ltd. as provided in items 5(a) (i) (ii) and (iii) or subparagraph 5(c) of the Settlement Agreement or cured by John Paul DeJoria as provided in subparagraph 5(b) therein;

WHEREAS, a Withdrawal of Filing of Judgment/Lien Without Prejudice was recorded in the Assignment Division of the United States Patent and Trademark Office on November 6, 2000, at Reel 002262, Frame 0118;

WHEREAS, full payment has been made to Seagram Ltd. pursuant to the terms of the Settlement Agreement;

NOW, THEREFORE, Seagram Ltd. hereby withdraws its Recordation with prejudice.
