TRADEMARK ASSIGNMENT

Boreham Jr. Street, Fort Smith, Arkansas 72908, its successors and assigns, the entire right, title and interest for all countries in and to the trademarks listed on the attached schedule (hereinafter the "MARKS"), together with the good will symbolized by the MARKS, and all other rights which ASSIGNOR has enjoyed thereunder, including any and all rights and remedies based on past infringement of said MARKS and/or registrations including the right to sue and collect damages and profits for such infringement, the same to be held and enjoyed by the ASSIGNEE, its successors and assigns.

For said consideration, ASSIGNEE hereby agrees, upon the request and at the expense of said ASSIGNEE, to execute and agrees to perform any affirmative acts and execute all documents necessary to obtain said domestic or foreign certificates of registration of said MARKS, and vest in said ASSIGNEE all rights therein, whereby said MARKS will be held and enjoyed by said ASSIGNEE, to the full end of the term for which said MARKS may be granted as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this assignment had not been made.

In the event that ASSIGNEE is unable for any reason to secure ASSIGNOR's or a duly authorized representative thereof's signature to any document required to file, prosecute, register, or memorialize the assignment of the right, title and interest assigned hereunder, the undersigned hereby irrevocably designates and appoints ASSIGNEE and ASSIGNEE's duly authorized officers and agents of its managing member as ASSIGNOR's agents and attorneys-in-fact to act for and on ASSIGNOR's behalf and instead of ASSIGNOR: (i) to execute, file, prosecute, register and memorialize the assignment of any such application, (ii) to execute and file any documentation required for such enforcement, and (iii) to do all other lawfully permitted acts to further the filing, prosecution, registration, memorialization of assignment, issuance, and enforcement of said assigned right, title and interest, all with the same legal force and effect as if executed by ASSIGNOR.


