**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS RELEASE (the "Release") is given as of this 31<sup>st</sup> day of August, 2001 by PNC BANK, NATIONAL ASSOCIATION, a national banking association having an office at Two Tower Center Boulevard, East Brunswick, New Jersey 08816 (hereinafter "Releasor") to HOGIL PHARMACEUTICAL CORP., a New York corporation with its principal place of business at Two Manhattanville Road, Purchase, New York 10577-2188 (hereinafter "Releasee").

1. **Preliminary Statement.** Releasee granted a security interest in the trademarks which are listed in Exhibit A attached hereto and made a part hereof (the "Trademarks") pursuant to a security agreement executed in connection with a loan extended by Releasor to Releasee dated May 2, 1997 (the "Security Agreement"). Releasee is requesting that the security interest held by Releasor on the Trademarks be released as of the date hereof and that the Releasor execute this Release to confirm that the Trademarks have been released from the lien of Releasor's security interest.

2. **Release.** For valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Releasor hereby releases and forever discharges (i) its security interest in and to the Trademarks, and (ii) the Trademarks from any security documents which were executed and delivered to Releasor. This Release is expressly limited to the Trademarks and shall not effect the security interest in any other property owned by Releasee.

3. **Further Assurances.** Releasor agrees, at Releasee's expense, to execute any additional documents or perform any further acts which may be reasonably required to effectuate the release of the security interest of Releasor in the Trademarks.

4. **Binding Effect.** This Release is binding upon the Releasor as well as its successors and assigns.


5. **Governing Law.** This Release shall be interpreted and governed by the laws of the State of New York.
