ASSIGNMENT OF TRADEMARKS

Assignee does hereby sell, convey, transfer, assign and deliver unto Assignee, and its successors and assigns, all of Assignor's right, title, and interest in and to the Registrations, together with the good will of the business symbolized by the Registrations in the United States of America and its territories and in all foreign countries, including, but not limited to, all common law rights, federal and state statutory rights, all rights to secure trademark registrations therein and to any resulting registrations in Assignee's name as claimant, any and all renewals thereof and all claims, demands, and rights of action which Assignor has, or may have in the future, by reason of any infringement (including past infringement) on the Registrations being assigned pursuant to this Assignment (including any infringement prior to this assignment), with all of the foregoing TO HAVE AND TO HOLD, unto Assignee, its successors and assigns, FOREVER.
2. Assignor further agrees to execute any and all powers of attorneys applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Assignee, its successors, assigns and legal representatives.
3. This Assignment of Trademarks shall be binding upon, inure to the benefit of and be enforceable by, Assignor and Assignee and their respective permitted successors and assigns.

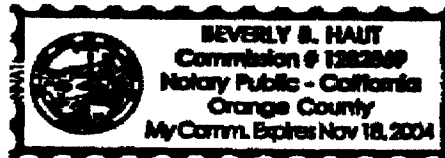
