Monsanto Company, a corporation organized and existing under the laws of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated on the 19th day of April, 1933, pursuant to the Corporation Law of the State of Delaware.

SECOND: That this corporation owns all of the outstanding shares (of each class) of the stock of Delfia, Inc., a corporation incorporated on the 23rd day of April, 1970, pursuant to the Corporation Law of the State of Delaware.

THIRD: That this corporation owns all of the outstanding shares (of each class) of the stock of Fovil Manufacturing Company, Inc., a corporation incorporated on the 29th day of August, 1977, pursuant to the Corporation Law of the State of Delaware.

FOURTH: That this corporation owns all of the outstanding shares (of each class) of the stock of Hagbee, Inc., a corporation incorporated on the 15th day of March, 1994, pursuant to the Corporation Law of the State of Delaware.

FIFTH: That this corporation determined to and did merge into itself said Delfia, Inc., Fovil Manufacturing Company, Inc., and Hagbee, Inc. by the following resolutions of its Executive Committee, adopted by unanimous written consent of its members on June 23, 1995 and filed with the Minutes of the proceedings of such Committee, with such Executive Committee acting pursuant to express authority delegated to it by this corporation's Board of Directors, pursuant to resolution duly adopted at a meeting held on the 24th day of February, 1995:

RESOLVED, that Monsanto Company merge, and it hereby does merge, into itself its wholly owned subsidiaries, Delfia, Inc., Fovil Manufacturing Company, Inc. and Hagbee, Inc., and assumes all of their respective liabilities and obligations;

.....

FURTHER RESOLVED, that the mergers shall be effective upon the date of the respective filings with the Secretary of State of Delaware; and

FURTHER RESOLVED, that any officer or assistant officer of the corporation be and he or she is hereby directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge said ... Delfia, Inc., Fovil Manufacturing Company, Inc. and Hagbee, Inc., and to assume their respective liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State and to do all acts and things whatsoever, whether within or without the State of Delaware, including, without limitation, execution and delivery of any and all documents, agreements, covenants, consents, notices, and other materials which may be in any way necessary, advisable, or proper to effect said mergers.
