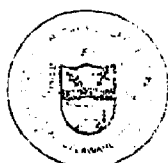

FIRST: That the name and state of incorporation of each of the constituent corporations of the merger is as follows:

FOURTH: The name of the surviving corporation of the merger is Creative Data Services, Inc., a Delaware corporation.

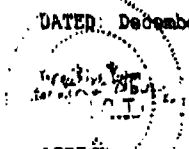
