TO THE

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

ARTICLE ONE.

The name of the Corporation is Alumet Building Products, Inc.

ARTICLE TWO.

The following amendments to the Articles of Incorporation were adopted by the shareholders of the Corporation on the 20th day of February, 1998.

The amendment alters Article One of the amended Articles of Incorporation to read as follows:

Article I  
The name of the corporation is Alumet Building Products, Inc.

ARTICLE THREE.

The number of shares of the Corporation outstanding at the time of such adoption was 872,000 and the number of shares entitled to vote thereon was 872,000.

ARTICLE FOUR.

The number of shares that voted for the amendment was 648,163; and the number of shares that voted against the amendment was 0.
