"Article I of the Certificate of Incorporation is hereby deleted in its entirety and the following Article I is inserted in lieu thereof:



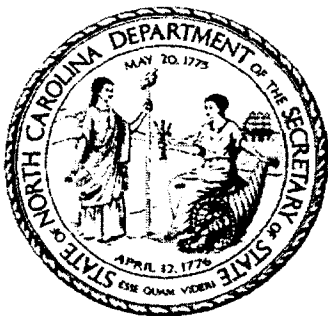
