## ASSIGNMENT OF TRADEMARKS AND GOODWILL

2. GLAD warrants, covenants and represents the fact to be that it is the owner of said trademarks and certificates of trademark registration, and that it has the full right to convey the entire interest hereby assigned.
3. The trademarks and certificates of trademark registration hereby assigned are used and registered in the United States of America.

4. GLAD further covenants with AA/STP to execute when requested such additional assignments, instruments and documents as may be necessary or desirable to effectuate this agreement and assignment.


