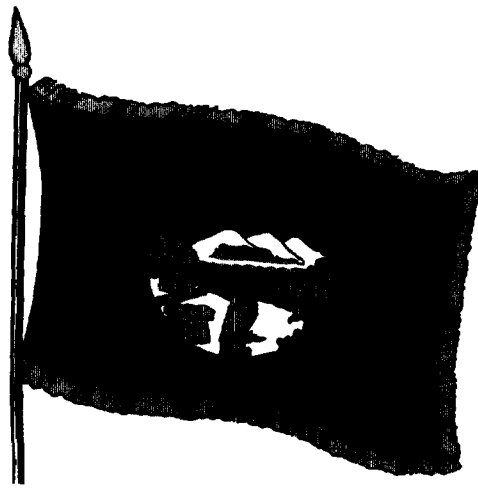

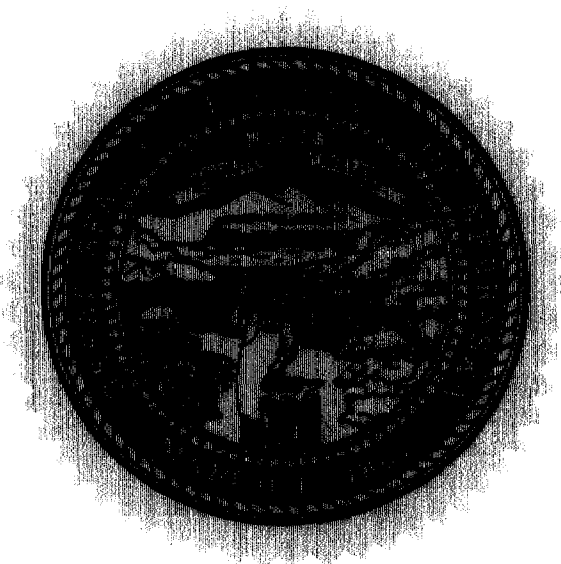

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
CHIEF TRANSPORTATION, INC.**

Chief Transportation, Inc. (the "Corporation") acting by and through its Board of Directors and sole shareholder adopts the following amendment to its Articles of Incorporation:

1. The name of the Corporation prior to the adoption of this amendment is "Chief Transportation, Inc."
2. The name of the Corporation shall be changed to "Chief Transportation Products, Inc."
3. The foregoing amendment was adopted by action of the Board of Directors and the sole shareholder of the Corporation on June 26, 2001.
4. At the time of adoption of this amendment, the Corporation had a single class of common stock, one thousand (1000) shares were issued and outstanding, and all issued and outstanding shares were voted in favor of the amendment.
