ASSIGNMENT AND LICENSE OF U.S. TRADEMARK

FOR AND IN CONSIDERATION of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, **BENDER GLICK APPAREL GROUP, INC.**, an Illinois corporation ("Assignor"), does hereby sell, assign, transfer and set over to **FYC INTERNATIONAL, INC.**, a New York corporation ("Assignee"), all of Assignor's rights, title and interest in, to and under the trademark **ROBBIE BEE** and the U. S. trademark registration number R0755565 which relates thereto (the "Mark"), free and clear of all liens and incumbrance, together with the goodwill of the business symbolized by the Mark and all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement, said rights to be held and enjoyed by said Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by said Assignor if this Assignment and sale had not been made, subject only to the rights granted to Assignor by Assignee herein.

Assignee hereby grants to Assignor a non-exclusive, royalty-free right and license to use the Mark in connection with the manufacture and sale of dresses throughout the Fall, 1992 season. Assignor shall have the right to continue to use the Mark in connection with the sale of dresses which are in its possession or control upon the conclusion of the Fall, 1992 season, and in connection with the sale of dresses returned to Assignor's possession or control at any time thereafter.
