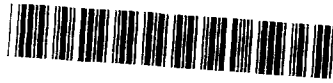

ASSIGNMENT


