WHEREAS, Ground Control Landscaping, Inc., a Florida corporation with an address of 2169 N. reason of past infringement of said trademark and trademark registration, with the right to sue for and collect the same for its own use and behalf, and for the use and behalf of its successors, assigns or other legal representatives.

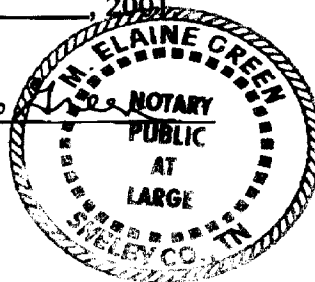
