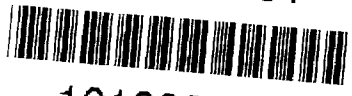
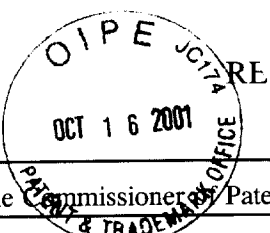

## TRADEMARK ASSIGNMENT
