NUNC PRO TUNC ASSIGNMENT OF TRADEMARKS

WHEREAS, on August 12, 1999, an Assignment of Trademark was executed and subsequently recorded with the Patent and Trademark Office at Reel No. 001945, Frame 0313 (the "1999 Assignment"),

WHEREAS, the 1999 Assignment incorrectly identifies Concentra Managed Care, Inc. ("Assignor") and Concentra Operating Corporation ("Assignee") as Massachusetts corporations. In reality, Concentra Managed Care, Inc. has been and currently is a Delaware corporation and Concentra Operating Corporation has been and currently is a Nevada Corporation. This mistake was a clerical error, and was made without intent to deceive any third party,

WHEREAS, both Assignor and Assignee now wish correct this error by executing and recording this Nunc Pro Tunc Assignment, which is materially identical to the 1999 Assignment, except for correctly identifying Concentra Managed Care, Inc. as a Delaware corporation instead of a Massachusetts corporation, and correctly identifying Concentra Operating Corporation as a Nevada corporation instead of a Massachusetts corporation, and further intends this Nunc Pro Tunc Assignment to be effective as of the date of execution of the 1999 Assignment,

NOW, THEREFORE, Assignor and Assignee hereby correct the 1999 Assignment by executing the Nunc Pro Tunc Assignment found below:
