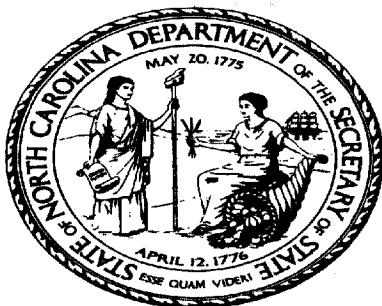

ARTICLES OF AMENDMENT
OF THE
ARTICLES OF INCORPORATION
OF
NOELL, SANDERS & WHITE, INC.

The undersigned Noell, Sanders & White, Inc., a North Carolina corporation, does hereby cause these Articles of Amendment to be executed in its corporate name for the purpose of amending its Articles of Incorporation:

(1) The name of the Corporation is NOELL, SANDERS & WHITE, INC.

(2) The following amendment to the charter of the Corporation was adopted unanimously by the Board of Directors and submitted to and unanimously approved by the sole Shareholder of the Corporation by formal written consents thereto as of the 27th day of January, 1989:

RESOLVED, that Article 1 of the Articles of Incorporation of the Corporation, be and hereby is deleted in its entirety and that the following provision be and hereby is substituted in its place and stead:

1. The name of the Corporation is Paula P. White & Associates, Inc.

(3) At the time of the adoption of said amendment there were one hundred (100) shares of a single class of common capital stock of the Corporation issued and outstanding. The number of shares of said common stock voted in favor of the amendment reproduced hereinabove was one hundred (100) and the number voted against the amendment was zero.

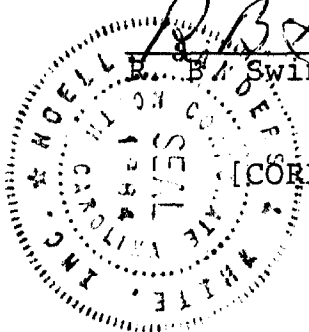

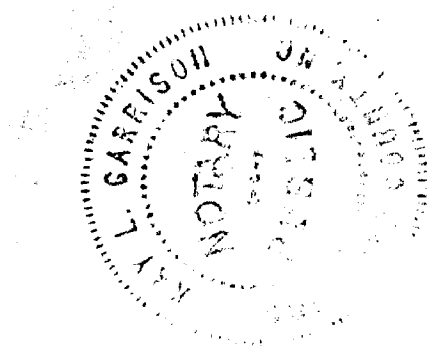
