RELEASE AND REASSIGNMENT

THIS RELEASE AND REASSIGNMENT is executed as of October 23, 2001 by ISRAEL DISCOUNT BANK OF NEW YORK, as successor in interest to ISRAEL DISCOUNT BANK LIMITED, LOS ANGELES AGENCY ("Lender").

W I T N E S S E T H:

WHEREAS, **BIG DOG HOLDINGS, INC.**, a Delaware corporation ("Company") and Lender are parties to a certain Trademark Security Agreement, dated as of June 30, 1995 (the "Agreement") pursuant to which Company incurred certain liabilities to and granted a security interest in and collateral assignment of the "Trademark Collateral" (as defined in the Agreement), including, without limitation, the trademark registrations and applications for trademark registration issued thereon or applied for in the United States or throughout the world, including registrations, recordings, supplemental registrations and pending applications for registration in the United States Trademark Office (collectively, the "Registrations") as described in Schedule A attached hereto, as security for Company's obligations to Lender under the Agreement;

WHEREAS, the Agreement was submitted for recordation with the United States Trademark Office on or about September 5, 1995, at Reel 1416, Frame 0414; and

WHEREAS, Company has satisfied its obligations under the Agreement and has requested that Lender release its security interest in the Trademark Collateral and reassign the same to Company;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Lender hereby releases, without any representation, warranty, or recourse whatsoever, its security interest in and collateral assignment of the Trademark Collateral and the goodwill associated thereto.


2. Lender hereby reassigns, grants and conveys to Company, without any representation, warranty, or recourse whatsoever, all of Lender's right, title and interest, if any, in and to the Trademark Collateral, including without limitation all of the Registrations appearing in Schedule A and the goodwill associated thereto.
