THOMAS PARR and JAMES PARR hereby certify that:

- 1. They are the duly elected and acting President and Secretary, respectively, of Amitec Cosmetics (the "Corporation"), a California corporation.
- 2. The Articles of Incorporation of this Corporation are hereby amended to read as set forth in full below and restated as so amended (with the omissions mandated by California Corporations Code Section 910(a)) as follows:

FIRST. The name of the corporation is:


