RELEASE AND REASSIGNMENT

This RELEASE AND REASSIGNMENT, dated as of January 3, 1997, is made by FLEET CAPITAL CORPORATION, a Rhode Island corporation (f/k/a Shawmut Capital Corporation (f/k/a Barclays Business Credit, Inc.)), having a mailing address at 200 Glastonbury Boulevard, Glastonbury, Connecticut 06033 ("Assignor") and IGLOO PRODUCTS CORP., ("Assignee") a Delaware corporation having a mailing address at 1001 W. Sam Houston Parkway, N. Houston, Texas 77403.

W I T N E S S E T H

WHEREAS, Assignee entered into a Loan and Security Agreement, dated as of December 2, 1994 (the "Loan Agreement") with Assignor and various financial institutions named therein ("Lenders");

WHEREAS, in connection with the Loan Agreement, Assignee executed and delivered a Trademark Collateral Security Agreement dated as of December 2, 1994 (the "Security Agreement") granting and conveying to Assignor for the ratable benefit of Lenders a security interest in and to:

- (a) the entire right, title and interest of Assignee in and to the Trademarks, as defined in the Security Agreement, including the registrations and applications appurtenant thereto, listed in Schedule A hereto, and in and to any and all trademarks and registrations and applications appurtenant thereto, hereafter acquired or filed by Assignee, including without limitation all renewals thereof, all proceeds of infringement suits, the rights to sue for past, present and future infringements and all rights corresponding thereto in the United States and the goodwill of the business to which each of the Trademarks relates; and
- (b) all of Assignee's right, title and interest in, to and under the following:

- (i) all Licenses designated on Schedule I hereto;
- (ii) all Accounts (as defined in the Security Agreement), contract rights and General Intangibles (as defined in the Loan Agreement) arising under or relating to each and every License (including, without limitation, (A) all moneys due and to become due under any License, (B) any damages arising out of or for breach or default in respect of any such License, (C) all other amounts from time to time paid or payable under or in connection with any such License, and (D) the right of Assignee to terminate any such License or to perform and to exercise all remedies thereunder); and
- (iii) to the extent not otherwise included, all Proceeds (as defined in the Security Agreement) and products of any or all of the foregoing;

(collectively, the "Collateral") to secure prompt payment of all Obligations of Assignee (as set out in the Loan Agreement);

WHEREAS, in order to further secure all Obligations as set out in the Loan Agreement and the Security Agreement, the Assignee entered into a Trademark Assignment of Security with Assignor, dated as of December 2, 1994 ("Assignment"), recorded in the United States Patent and Trademark Office on December 7, 1994, at Reel/Frame 1258/0326, pursuant to which Assignee assigned and granted to Assignor, for the ratable benefit of Lenders, a security interest in and to the trademarks set out in

Schedule A of the Assignment (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks, and registration and applications therefor;

WHEREAS, the Obligations (as defined in the Loan Agreement) have been satisfied and Assignor no longer claims an interest in the Collateral, including the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, Assignor hereby agrees and confirms that the Loan Agreement, the Security Agreement and the Assignment and any and all rights and interests conveyed or granted thereby are terminated and released, and any and all rights of Assignor in the Collateral are hereby reassigned to Assignee.
