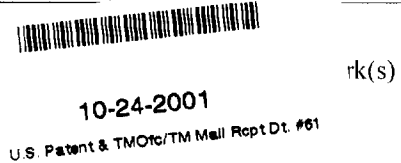

ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT (the "Agreement") is made and entered into as of December 20, 1999, by and between Miriam Collins Palm Beach Laboratories Co. ("Seller"), a Minnesota corporation, and HIJ, LLC ("Buyer"), a Minnesota limited liability company.

Seller and Buyer (the "Parties") desire that Seller sell, transfer and assign to Buyer, and Buyer purchase from Seller, all of the assets and businesses of Seller (the "Business"), excluding only the Excluded Assets (as defined below), on the terms and for the consideration provided in this Agreement.

In consideration of the respective representations, warranties, covenants and agreements contained in this Agreement, and subject to the terms and conditions set forth in this Agreement, the Parties agree as follows:

ARTICLE 1 PURCHASE AND SALE OF ASSETS

1.1 Purchased Assets. Upon the terms and subject to the conditions set forth in this Agreement, effective as of the Closing (defined in Section 8.1), Seller shall sell, transfer, assign and convey to Buyer, and Buyer shall purchase, all the assets, properties, rights, interests, claims and business of Seller, as of the Closing, of every kind, nature and description, wherever located, whether now owned or hereafter acquired, whether tangible or intangible, real, personal or mixed, absolute or contingent, known or unknown, including (unless otherwise indicated in this Agreement), but not limited to the following (collectively, the "Assets"): (i) all inventories, accounts receivable, prepaid expenses, insurance policies, Intellectual Property (defined in Section 2.1(c)), Contracts (defined in Section 2.1(d)), Authorizations (defined in Section 2.10), furniture, equipment, tooling, molds, vehicles, marketing and sales materials, customer lists, business records, ledgers, books of account, and goodwill of Seller's business and operations, (ii) all of the assets listed on Schedule 2.1(b), and (iii) all of the assets, properties, rights, interests, claims and business reflected in the balance sheet of the Business as of a date no earlier than 1 business day before December 20, 1999 (the "Governing Balance Sheet"), prepared in accordance with generally accepted accounting principles and procedures consistently applied, and only with such changes as shall have occurred in the ordinary course of business and in compliance with this Agreement, but expressly excluding from the definition of Assets only the Excluded Assets.

1.2 Excluded Assets. Seller shall retain all of Seller's right, title and interest in and to, and there shall be excluded from sale, assignment or transfer to Buyer under this Agreement, only the assets listed on Schedule 1.2 (the "Excluded Assets"). Except as provided in Schedule 2.1(b), no Excluded Assets shall be included on the Governing Balance Sheet.

"Intellectual Property" means letters patent and patent applications; tradenames, trademarks, servicemarks and any registrations thereof and applications therefor; copyrights and copyright registrations and applications; and inventions, discoveries, ideas, technology, know-how, trade secrets, processes, formulas, drawings and designs, computer software programs or hardware; and all amendments, modifications and improvements to any of the foregoing. As part of Schedule 2.1(c), Seller shall deliver to Buyer true and complete copies of all issuances, registrations, applications, disclosures, and certificates regarding such Intellectual Property, true and complete copies of all contracts with employees or others relating in whole or in part to disclosure, ownership, assignment or patenting of inventions or discoveries, confidential or proprietary information, product formulas, know-how, trade secrets or other Intellectual Property, and true and complete copies of all patent, trademark, trade name, copyright, know-how, trade secret or other Intellectual Property licenses granted at any time by or to Seller or for the conduct of the Business.


