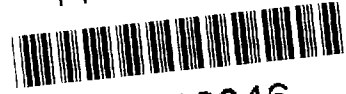


**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**
