**ARTICLES OF AMENDMENT
OF

The undersigned being the President of Diesel Engines, Inc., a Delaware corporation ("Corporation"), hereby submits these Articles of Amendment for the purpose of amending the Certificate of Incorporation of the Corporation, pursuant to Section 242 of the Delaware Corporation Law.

The following amendments to the Corporation's Certificate of Incorporation was proposed by the Corporation's Directors, and adopted by its shareholders, pursuant to Section 223 of the Delaware Corporation Law.

Article I is hereby amended to state:

FIRST. The name of the corporation is Diesel & Gas Turbine Publications, Inc.

Article IV of the Certificate of Incorporation of Diesel Engines, Inc. is hereby amended to state:

FOURTH. The total number of shares of stock which the corporation shall have authority to issue is forty thousand (40,000); all of such shares shall be without par value.
