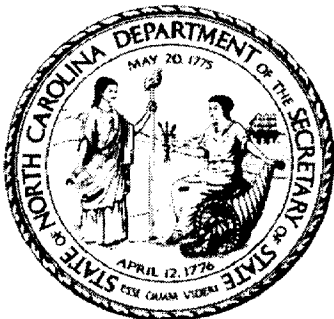

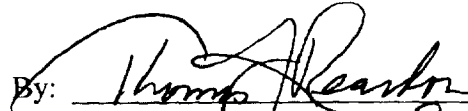
The First Article is amended and restated in its entirety as follows:
