**AMENDED ORDER GRANTING MOTION OF HILLCREST BANK  
FOR ORDER NUNC PRO TUNC  
CLARIFYING ORDER FOR RELIEF FROM THE AUTOMATIC STAY**

COMES on for consideration Hillcrest Bank (the "Bank"), by and through undersigned counsel, Cynthia F. Grimes of Grimes & Rebein, L.C., and hereby moves this Court for an Order Nunc Pro Tunc Clarifying Order for Relief From the Automatic Stay. Notice with opportunity for nonevidentiary hearing was mailed to all interested parties, no objections were filed and no hearing was held on this matter. The Court, being well and fully advised in the premises, finds as follows:

1. These cases were commenced by the filing of voluntary Chapter 11 petitions for relief on October 27, 1997.
2. These cases were converted to Chapter 7 cases on January 24, 2000.
3. The Bank holds a valid lien in all assets including all general intangibles. General intangibles include, *inter alia*, trademark registrations, common law trademark rights and trade names, together with goodwill symbolized by the marks.
