**ASSIGNMENT AGREEMENT
(Trademark)**

THIS ASSIGNMENT AGREEMENT (TRADEMARK), is made as of April 26 2000 (this "Agreement"), by and between PRIMUS HOLDINGS, L.P., a Delaware limited partnership ("Assignor") and TRISTAR ENTERPRISES, L.L.C. a Delaware limited liability company ("Assignee").

W I T N E S S E T H:

WHEREAS, pursuant to that certain Asset Purchase Agreement (the "Asset Purchase Agreement") dated of even date herewith, by and between Assignor and Assignee, Assignor has undertaken to and did this day transfer to Assignee all its right title and interest in and to certain trademarks and trademark rights more particularly described herein; and

WHEREAS, pursuant to the Asset Purchase Agreement, Assignor desires to execute and deliver this Agreement in order to effectuate the transfer and assignment to Assignee of such trademarks and trademark rights.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby agrees, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the respective meanings provided or provided by reference in the Asset Purchase Agreement.

SECTION 2. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign and transfer to Assignee all of its right, title and interest in and to all of the following property (the "Trademark Property"), whether now or hereafter owned, existing or arising:

(a) those certain trademarks, trade names, corporate names, company names, business names, fictitious business names, trade dress, service marks, certification marks, collective marks, logos, other sources of business identifiers, designs and general intangibles of a like nature (each of the foregoing items in this clause (a) being called a "Trademark"), now existing, whether currently in use or not, including all registrations therefor and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office or in any office or agency of the United

States of America or any State thereof or any foreign country, referred to in Item A of Attachment 1 hereto;

(b) those certain Trademark licenses referred to in Item B of Attachment 1 hereto;

(c) any reissues, extensions or renewals of any of the items described in clauses (a) and (b);

(d) all of the goodwill of the business connected with the use of, and symbolized by the items described in clauses (a) and (b); and

(e) all proceeds of, and rights associated with, the foregoing, including any claim by Assignor against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license referred to in Item A and Item B of Attachment 1 hereto, or for any injury to the goodwill associated with the use of any such Trademark or for breach or enforcement of any such Trademark license.


