# ASSIGNMENT AND RELEASE OF SECURITY INTEREST

This assignment and release of security interest, dated as of 1st ~~September~~ <sup>October</sup> 2001, is given by Royal Bank of Canada, having its principal place of business at 5th Floor, South Tower, 200 Bay Street, Toronto, Ontario, M5J 2J5, to Associated Brands Inc., having its principal place of business at 335 Judson Street, Toronto, Ontario M8Z 1B2.

WITNESSETH:

WHEREAS, Royal Bank of Canada and Nadiscorp Limited are parties to a Facility Agreement dated as of February 23, 1998;

WHEREAS, all obligations of Nadiscorp Limited under the Facility Agreement were secured pursuant to a Patent, Trademark and License Assignment, dated as of March 2, 1998, which was recorded in the U.S. Patent and Trademark Office on March 9, 1998, at Reel 1713, Frame 0023;

WHEREAS, Nadiscorp Limited and other corporations filed Articles of Amalgamation effective January 1, 1999 to form Associated Brands Inc., which were recorded at the U.S. Patent and Trademark Office on June 29, 1999, at Reel 1927, Frame 0445;

WHEREAS, pursuant to the Patent, Trademark and License Assignment Nadiscorp Limited granted to Royal Bank of Canada the entire right, title and interest of Nadiscorp Limited in and to all of the following property whether then owned or thereafter acquired or arising and filed: the items listed under paragraphs 2(a)(i), 2(a)(ii), 2(a)(iii), and 4.

WHEREAS, pursuant to the Patent, Trademark and License Assignment Nadiscorp Limited granted to Royal Bank of Canada a security interest in the following property: the items listed in paragraph 2(b)(i), 2(b)(ii), and 4.

WHEREAS, all obligations of Nadiscorp Limited under the Facility Agreement have been satisfied and all liabilities of Nadiscorp have been paid in full, and Associated Brands Inc. has requested Royal Bank of Canada to assign all of the properties that were assigned to Royal Bank of Canada under the Patent, Trademark and License Assignment to Associated Brands Inc.




