**RELEASE OF CERTAIN TRADEMARKS UNDER TRADEMARK  
SECURITY AGREEMENT**

RELEASE, dated July 5, 2001 granted by Citicorp USA, Inc. ("Lender").

**W I T N E S S E T H :**

WHEREAS, **Pace International, LLC** ("Borrower") and **Citicorp USA, Inc.** ("Lender"), have entered into a Trademark Security Agreement, dated as of May 10, 2000, (the "Trademark Security Agreement"), pursuant to which the Borrower granted to the Lender a security interest in all of the Trademarks and Licenses (as such terms are defined in the Trademark Security Agreement);
