**SERVICE MARK  
SECURITY INTEREST RELEASE**

WHEREAS, Worldwide Flight Services, Inc., a Delaware corporation, located at 1001 West Eules Boulevard, Suite 320, Eules, Texas 76040 (the "Debtor") and The Chase Manhattan Bank, located at 270 Park Avenue, New York, NY 10017 ("Chase"), as Administrative Agent (as defined in the Security Agreement dated as of August 12, 1999 (the "Agreement")), that by its terms granted Chase a security interest in certain marks as listed in Schedule V to the Agreement and reproduced on the Schedule attached hereto (collectively, the "Collateral").
