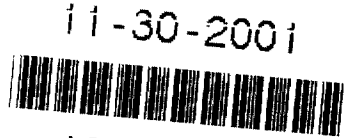

## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made as of June 28, 2001 by and among GREAT WESTERN DIRECTORIES, INC., a Texas corporation, PACIFIC COAST PUBLISHING, LTD, a Washington corporation, CHOICECONTENT.COM, INC. (f/k/a Web YP, Inc.), a Texas corporation (collectively, the "Grantors") and BANK OF AMERICA, N.A. ("Grantee").

**WHEREAS**, pursuant to the terms and conditions of those certain Trademark Security Agreements by and between Grantors and Grantee dated February 23, 2000 (the "Trademark Security Agreements"), Grantors granted to Grantee a continuing security interest in the entire right, title and interest in and to the registered trademarks, service marks and trade names together with the associated trademark, service mark and trade name applications and registrations (collectively, the "Trademarks") set forth in Schedule A attached hereto;

**WHEREAS**, the Trademark Security Agreements executed by Great Western Directories, Inc., Web YP, Inc. and Pacific Coast Publishing, Ltd. were recorded with the United States Patent and Trademark Office ("PTO") on May 26, 2000, at Reels 002087, 002086 and 002087, Frames 0255, 0471 and 0215, respectively;

**WHEREAS**, Grantors have paid all of their outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.


Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register the foregoing, or any trade name or assumed name, other than those of the foregoing set forth in Schedule A attached hereto, in any jurisdiction throughout the world; and (iv) Schedule B attached hereto sets forth a complete and correct list of all of the filings made by or on behalf of Grantee to record or otherwise evidence any security interest it has against the Trademarks in any jurisdiction throughout the world.


