further lawful acts, deemed necessary or expedient by said ASSIGNEE or by counsel for ASSIGNEE, to assist or enable said ASSIGNEE to obtain and enforce full benefits from the rights and interests herein assigned. ASSIGNOR additionally agrees to execute copies of this assignment or portions thereof regarding any or all of the aforementioned MARKS, as required by ASSIGNEE in the future.

3. ASSIGNOR of the aforesaid MARKS hereby agrees to waive all rights and privileges to attack any of the MARKS or the registration of any or all of the aforesaid MARKS.

4. ASSIGNOR represents and warrants that it is the sole and exclusive owner of the MARKS and that the MARKS are free of all liens, security interests, claims or other encumbrances except where specifically noted.

5. ASSIGNOR will not adopt and/or use any mark which is a colorable imitation that is likely to cause confusion with any of the MARKS.
