ASSIGNMENT OF TRADEMARKS

The Assignor agrees to cooperate in the Assignee's registration, recordation of title, maintenance, and protection of the Marks, and the Assignor agrees to execute any documents reasonably requested by the Assignee for this purpose and to perform such acts as the Assignee may deem necessary to secure to the Assignee the rights herein conveyed.

This assignment is made on an as is where is basis, without recourse or any representation or warranty expressed or implied, including any warranties as to title or as to merchantability and fitness for a particular purpose, all of which are expressly disclaimed, and Assignee hereby acquires and purchases the Assets from Assignor on such terms.
