ASSIGNMENT OF TRADEMARK

WHEREAS, WALDEN-HAYS, INC., a New York corporation having a principal place of business at 852 Broadway, New York, New York 10003, (hereinafter referred to as ASSIGNOR), is the owner of the trademark and record owner of the United States Trademark Registration for UFO in Class 9 for sunglasses, eyeglasses and cases for sunglasses and eyeglasses, (Registration No. 2,065,600), (hereinafter referred to as the TRADEMARK); and

WHEREAS, UFO CONTEMPORARY, INC., a New York corporation, having a principal place of business at 466 Broome Street, New York, New York 10013 (hereinafter referred to as ASSIGNEE), is desirous of acquiring all of the right, title and interest of ASSIGNOR in, to and under the TRADEMARK, together with the goodwill of the business associated with the TRADEMARK; and

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR hereby transfers and assigns to ASSIGNEE the entire right, title and interest of ASSIGNOR in and to the TRADEMARK together with the goodwill of the business associated with the TRADEMARK; and

ASSIGNOR, does hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representative;

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States to record the TRADEMARK as the property of ASSIGNEE; and

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARK herein assigned.
