by changing the name of the corporation to AT&T Corp.

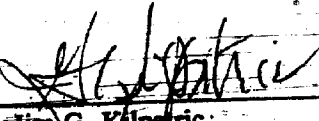
FOURTH: To accomplish the foregoing amendment, Article **FIRST** of the

subsequent to the unanimous vote of the Board of Directors.

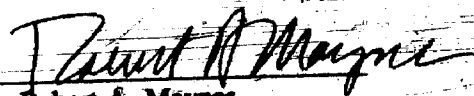
