R & R MARKETING, INC. also agrees that it shall never object to, protest or oppose the use and/or registration by MAYTAG CORPORATION of the Marks, for any goods or services other than ceiling fans. MAYTAG CORPORATION further agrees that it shall never object to, protest or oppose the use and/or registration by R & R MARKETING, INC. of the trademark "DYNASTY" for ceiling fans, as set forth in U.S. Registration No. 1,256,001.
