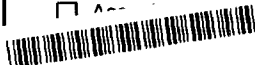


ASSIGNMENT

Neither Assignor nor any subsidiary or affiliated company of Assignor has made or will make any warranty whatsoever, express, implied or statutory, including without limitation any implied warranties of title, enforceability, validity or non-infringement.
